Administrative Matters

Call to Order and Roll Call

Ms. Carvalho called to order at 12:31 p.m. the meeting of the Board of Supervisors of the Windward at Lakewood Ranch Community Development District and proceeded with roll call. The persons in attendance are as outlined above.

SECOND ORDER OF BUSINESS Business Matters

Consideration of the Minutes of the October 14, 2020 Board of Supervisors' Meeting

The Board reviewed the Minutes of the October 14, 2020 Board of Supervisors' Meeting.

On MOTION by Mr. Williams, seconded by Mr. Blakely, with all in favor, the Board approved the Minutes of the October 14, 2020 Board of Supervisors' Meeting.

Ratification of Bond Financing Team Funding Agreement

Ms. Carvalho explained this is a standard agreement in anticipation of Issuance of Bonds for the District.

On MOTION by Mr. Williams, seconded by Ms. Foster, with all in favor, the Board approved the Bond Financing Team Funding Agreement.

Appointment of RFP Committee

Mr. Kennedy stated the next phase of the development is out to bid now and there is typically two ways to solicit proposals. One is a low bid and the second way is to do an RFP where pricing is 50% of the scoring and there are other criteria such as schedule, personnel, etc. Typically when a District does that a Committee is appointed by the Board who will then meet at an advertised meeting in the Sunshine and talk about the different submittals they get and score them and after that Committee Meeting will come back to the Board with a recommendation as to who the Committee thinks should be awarded the Contract. It is ultimately the Board's decision. After talking with various people the recommendation for Committee Members would be Mr. Kennedy, Mr. Hediger, and Mr. Wilhoit.

Mr. Vogler stated there are criteria that will be applied by the Committee as they consider the applicants and also that will form their recommendation to the Board but if the Board Members had any comments they wanted to make to the Committee Members now is an opportunity to say what is important to the Board. Mr. Weidemiller asked if insurance limits is one of the criteria in which the District is considering. Mr. Kennedy confirmed, and Mr. Vogler stated the financial health of the company is also part of that analysis. Mr. Kennedy stated that all of these contractors are pre-qualified. This RFP is project specific.

On MOTION by Mr. Williams, seconded by Mr. Blakley, with all in favor, the Board approved Mr. Kennedy's Recommendation to appoint the RFP Committee as presented and proceed with the advertisement.

The RFP Committee will coordinate with Mr. Vogler on advertising and setting up a location and date for their meeting. Mr. Vogler stated he would be happy to participate in

questions of timing but Ms. Ripoll and Ms. Carvalho manage the relationship with the newspaper for the advertisement.

Review & Consideration of 2020 Prequalified Contractors

Mr. Kennedy stated there was one Contractor added. He requested the list of Contractors that is listed in the agenda package be approved by the Board.

On MOTION by Mr. Williams, seconded by Mr. Blakley, with all in favor, the Board approved the 2020 Prequalified Contractors, as presented to add Quality Enterprises USA, Inc.

Consideration of Resolution 2021-03, Ratification of Revised Adopted Budget for Fiscal Year 2020

RESOLUTION 2021-03

THE REVISED ANNUAL APPROPRIATION RESOLUTION OF WINDWARD AT LAKEWOOD RANCH COMMUNITY DEVELOPMENT DISTRICT (THE "DISTRICT") RELATING TO THE REVISED ANNUAL APPROPRIATIONS AND ADOPTING THE REVISED BUDGET FOR THE FISCAL YEAR BEGINNING OCTOBER 1, 2019, AND ENDING SEPTEMBER 30, 2020

WHEREAS, the Windward at Lakewood Ranch Community Development District Board of Supervisors (the "Board") previously approved and adopted an annual budget for the fiscal year beginning October 1, 2019 and ending September 30, 2020, pursuant to the provisions of Section 190.008(2)(a), Florida Statutes; and

WHEREAS, the Board now desires to revise the annual budget for the fiscal year beginning October 1, 2019 and ending September 30, 2020; and

WHEREAS, Section 190.008(2)(a), Florida Statutes, requires that the District Board by passage of the Annual Appropriation Resolution shall adopt a budget for the each fiscal year and appropriate such sums of money as the Board deems necessary to defray all expenditures of the District during the ensuing fiscal year; and

WHEREAS, the District Manager has prepared a Proposed Budget, whereby the Proposed Budget projects the cash receipts and disbursements anticipated during a given time period, including reserves for contingencies for emergency or other unanticipated expenditures during the fiscal year.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF SUPERVISORS OF WINDWARD AT LAKEWOORD RANCH COMMUNITY DEVELOPMENT DISTRICT;

Section 1. Budget

- a. That the Board of Supervisors has reviewed the District Manager's Proposed Budgets, a copy of which is on file with the office of the District Manager and at the District's Records Office, and hereby approves certain amendments thereto, as shown in Section 2 below.
- b. That the District Manager's Proposed Budgets, attached hereto as Exhibit "A," are hereby adopted in accordance with the provisions of Section 190.008(2)(a), Florida Statutes, and incorporated herein by reference; provided, however, that the comparative figures contained in the adopted budget may be subsequently revised as deemed necessary by the District Manager to reflect actual revenues and expenditures for fiscal year 2019-2020.

c. That the adopted budget shall be maintained in the office of the District Manager and at the District's Records Office and identified as "The Revised Budget for the Windward at Lakewood Ranch Community Development District for the Fiscal Year Beginning October 1, 2019 and Ending September 30, 2020", as adopted by the Board of Supervisors on August 12, 2020.

Section 2. Appropriations

There is hereby appropriated out of the revenues of the Windward at Lakewood Ranch Community Development District, for the fiscal year beginning October 1, 2019, and ending September 30, 2020, the sum of money to be raised by the levy of assessments and otherwise, which sum is deemed by the Board of Supervisors to be necessary to defray all expenditures of the District during said budget year, to be divided and appropriated in the following fashion:

Section 3. Supplemental Appropriations

The Board may authorize by resolution, supplemental appropriations or revenue changes for any lawful purpose from funds on hand or estimated to be received within the fiscal year as follows:

- a. Board may authorize a transfer of the unexpended balance or portion thereof of any appropriation item.
- b. Board may authorize an appropriation from the unappropriated balance of any fund.
- c. Board may increase any revenue or income budget amount to reflect receipt of any additional unbudgeted monies and make the corresponding change to appropriations or the unappropriated balance.

The District Manager and Treasurer shall have the power within a given fund to authorize the transfer of any unexpected balance of any appropriation item or any portion thereof, provided such transfers do not exceed Ten Thousand (\$10,000) Dollars or have the effect of causing more than 10% of the total appropriation of a given program or project to be transferred previously approved transfers included. Such transfer shall not have the effect of causing a more than \$10,000 or 10% increase, previously approved transfers included, to the original budget appropriation for the receiving program. Transfers within a program or project may be approved by the Board of Supervisors. The District Manager or Treasurer must establish administrative procedures which require information on the request forms proving that such transfer requests comply with this section.
